	Members supported the vision of the Vice-Chancellor and commended the progress of the University.	
21.52 Determination of risk appetite	The Councils CONSIDERED its risk appetite for 2021/22 (JCO109).  The Senior Directorate had made a preliminary assessment of the risk appetite that might be adopted for the institutional priorities for 2021/22, as set out in <i>Agenda 2021/22</i> , using the assessment tool presented.  In discussion, members queried the conservative approach proposed for culture and values. The Vice-Chancellor clarified that this was to ensure that no risks were taken in respect of the Welsh language. Members also noted that it would be useful for future assessments to permit greater nuancing in respect of innovation.  The Councils APPROVED the risk appetite recommendation of officers. 21.53 Organisation culture	In the context of their commitments under the Governance Charter for Universities in Wales, the Councils CONSIDERED the first data report on organisation culture (JCO110).  Members noted that the report proposed a working definition of desired culture for consideration and drew together data from a range of sources. The Councils were asked to consider the working definition; consider if the data presented suggested that there were any gaps between the actual and desired culture; and determine, if applicable, what action was needed to close the gap to achieve the desired culture. Officers were also seeking advice on the contents and focus of future reports. Following preliminary discussion, the Councils AGREED that a meeting should be arranged to give focused attention to this matter.  Members were reminded that the Governance Charter also included a commitment from governing bodies, in their annual reports, to explain how key stakeholders had been engaged during the year. Camm had envisaged that this work would stem from a sector-wide 'good practice guide to ensure the effective engagement with key stakeholders and consideration of their views in the development of university strategy'.
